NARRATIVE

About 3:38 PM on Thursday, 11/30/23, Officer Michaud, while assigned to the E414D unit, responded to a radio call for a pedestrian struck at 1833 Centre St. in West Roxbury.

On arrival, Officer Michaud observed a white Jeep Grand Cherokee (MA REG [REDACTED]) in the middle of the roadway of Centre St. outbound. The vehicle was observed partially in the inbound, left turn lane. The operator, identified as [REDACTED], was standing outside his vehicle. Mr. [REDACTED] stated that he was traveling on Centre St. outbound when he went around the left side of a gray Ford F150 pickup (MA REG. # [REDACTED]) which was stopped in traffic. Mr. [REDACTED] stated he had not driven on Centre St. since a new traffic pattern was put in place, and stated he drove into what he believed was a lane of travel. Mr. [REDACTED] stated that he heard a thud and realized that he had struck a pedestrian.

Officer Michaud requested additional units to conduct traffic and the E-5 Auto Investigator to the scene. The ED20 arrived on scene along with the E912 (Sgt. Morash).

The operator of the pickup, identified as [REDACTED], remained on scene and was outside his vehicle. Mr. [REDACTED] stated that he was stopped in traffic, just outside of the marked crosswalk located at the intersection of Maple St. and Centre St. which crosses Centre St. Mr. [REDACTED] stated that he observed the white Jeep go around him on the left side and heard a thud. Mr. [REDACTED] stated that he initially thought that the vehicle had struck his. Mr. [REDACTED] stated that he observed the victim lying on the ground beside his vehicle on the left side.

Officer Michaud spoke with the victim, identified as [REDACTED]. Mr. [REDACTED] was sitting on a bench on the opposite side of the roadway, being attended to by Boston Fire Dept. personnel from Engine 30. Mr. [REDACTED] complained of a head injury and being faint stating "I feel like I'm going to pass out". Mr. [REDACTED] stated that he was in the crosswalk crossing from the Maple St. side of Centre St to the opposite (even) side of the roadway when he was struck, propelling him to the ground. Officer Michaud requested an ambulance to the scene. Boston EMS Ambulance 2A17 arrived and treated the victim for a large laceration on the head. He was transported the victim to the [REDACTED] Hospital for further treatment. The E626D (PO Smyth) accompanied the victim to the hospital.

It was observed by Officer Michaud, that at the time of the accident there was a solar glare in the outbound direction of travel due to the sun setting. Officer Michaud also observed new lines in the roadway due to a new traffic pattern that was initiated in the area of Centre St., which restricts the lanes of travel to one lane in each direction, which had previously been two lanes in each direction.

The scene was processed by Officer Parenteau (ED20). Both vehicles were allowed to leave, and all parties cleared the scene.
