### NARRATIVE

1. On Tuesday, March 10, 2009, at approximately 1707 hours, I, Officer Connolly (595), while assigned the W446, was dispatched to the Orange line platform of Forest Hills station for a report of an indecent assault and battery. On arrival to the platform I met with MBTA Inspector [REDACTED] T-8865 and "a victim known to the Commonwealth."
2. The victim stated on 1655 hours she was on an Orange line train to Forest Hills. As the train was stopped in between Green street station and Forest Hills station, a man next to her said "Hey baby you're beautiful" and started to rub his hand on the right side of her body. She told the man not to touch her and to leave her alone. The man then started to rub her left knee and thigh. She again told him not to ever touch her again. The man again started to rub her right side. The victim stood up and attempted to move away from the man. As she stood up the man then grabbed her buttocks. The victim then called Transit Police on her cell phone. After getting off the train at Forest Hills, she met with Inspector [REDACTED] telling him what had transpired and also pointing out the man who at this time had moved to an outbound Orange line train.
3. Both the victim and Inspector [REDACTED] described the suspect as an older, short, Hispanic male with a mustache wearing a base ball hat, a grey parka and carrying a bag with an alcoholic beverage in it. They further stated that the man was sitting on the second car immediately next to the first door. [REDACTED] had gotten contact with the Orange line train the suspect had left on and reported that it was being held outside of Stony Brook station.
4. I then contacted Transit Police dispatch and informed them of the situation. Officer Coulter W748 and Officer Almeida W746 met the train at Stony Brook station and found Jose Velasquez sitting next to the first door on the second train car. Velasquez is an older Hispanic male with a mustache and was wearing a baseball hat, a grey parka and also had possession of a brown bag containing an alcoholic beverage.
5. Officer Almeida and I brought the victim to Stony Brook station where she
